Technical Intervention to Protest Course

Specialist Training



Technical Intervention to Protest Training Course (CPD UK certified)

Developed by former Police Protest Removal trainers in conjunction with **Police and Security Industry professionals**, and delivered by experienced instructors, this innovative CPD UK Certified course provides learners with the knowledge and confidence to use Tools and Equipment including Glue Debonder and Hydraulic cutters to respond to protest events involving Adhesion Incidents (Glue ons) and Simple Ground level Lock on incidents on private property. Designed to continue the **Continuous Professional Development** for **Security Officers** proportionately dealing with protests, this course follows on from the CPD UK Certified 'Dealing with Incursion, Protest and Activism' course.

Course Design and Service Delivery

This **TIP Course** is the second in a training series, to develop and upskill relevant Security Officers (or other Staff) whether frontline or other, to be able to **effectively, safely and lawfully deal** with Adhesion incidents and Simple ground level lock ons during incursion, activist or protest situations on private property, and especially during live or time critical events. Prior to attending this course, students should have successfully completed the CPD UK accredited '**Dealing with Incursion, Protest and Activism**' (DWIPA) training which introduces them to the Legal Framework, the difference between civil & criminal law, protest on public and private property, and the awareness of relevant legislation in protest situations.

The TIP training course builds on this knowledge, developing the skills of the learners, and enabling them to navigate challenging Glue-on (Adhesion) or Simple Lock-on incidents proportionately, lawfully and safely.

The **instructors** are former **Police Commanders, Protest Removal Trainers** and **practitioners**. On successful conclusion of the course, Learners will receive a CPD UK Certified Certificate and all necessary Operational Documentation.

Training Objectives:

Module 01

Learners will understand the **5WH** approach to identifying the **What, Where, Why, Who and How** to address simple ground level Lock-on and Adhesion incidents and be able to relate the elements of the Decision-making Model and how the legal framework outlines your powers and responsibilities.

Module 02

Students will understand the **safe system of work** involved when dealing with Adhesion incidents, following the reasoning behind it and becoming competent in the practical application of the principles and use of debonder in a practical scenario.

Module 03

Recognise the 3 main types of Lock-on incidents, identify the various tactics and tools used by persons involved in these incidents and display competence in the **use of the tools and hydraulic equipment** in the practical removal of the Lock-on. They will be able to explain how they follow the safe system of work and Operational Documentation for Simple Lock on incidents.

Theory Examination

Learners will take the **theory examination** and are required to achieve a **60% pass rate**.

Practical Scenarios

Learners will demonstrate their understanding and competence in all aspects of the course in dealing with practical scenarios, and will use the operational documentation, and the **physical use of the tools and equipment** that they have been trained on.



Trainer Biographies

Kenny MacLeod BSc MSyl, the RMR Limited Training Manager, is a retired Police Superintendent with 30 years' Service. He is a former Bronze and Silver Public Order Commander who has accumulated significant operational experience in the Police; especially in relation to public protest, balancing the rights of individual protest with the right of other individuals to go about their lawful activity. More recently, Kenny has undertaken an advisory and liaison role within Industry and has been integral in the development and delivery of the **TIP and DWIPA courses** for the past **6 years**.

Trainer 2, is a former Strathclyde Police Officer and was a Protest Removal, Evidence Gathering and Public Order Trainer.

Trainer 3, is a former Strathclyde and Police Scotland Inspector. He was a former Bronze Public Order Commander, Public Order Trainer and Adviser and the regional lead for protest removal.

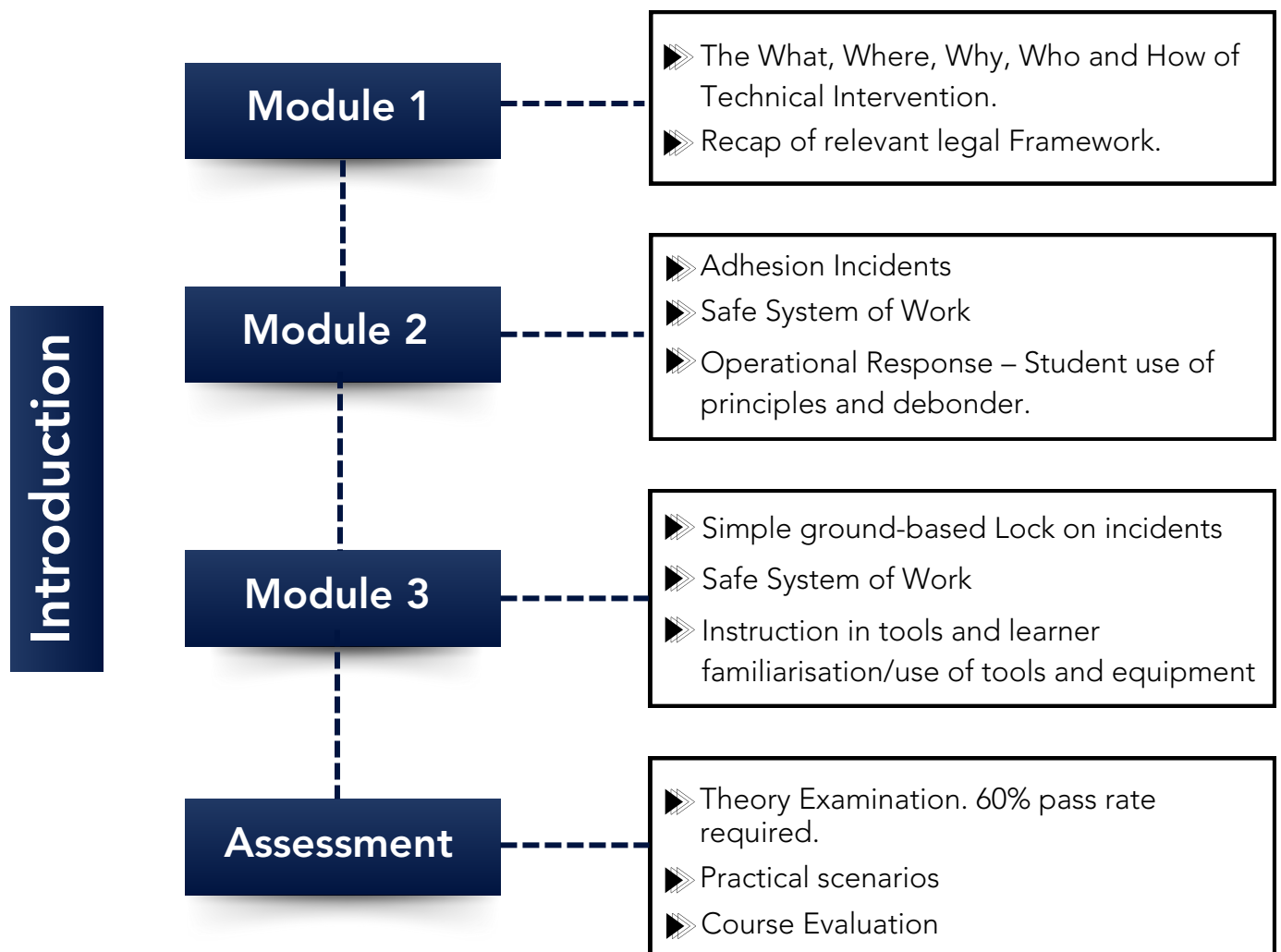

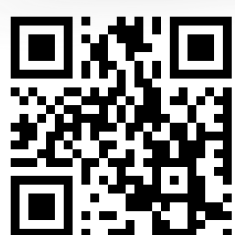
