## 2. Threat Monitoring

### ▶ Open-Source Threat Monitoring and Analysis

Our team utilises open source intelligence gathering techniques to identify and analyse potential threats, tactics, techniques, and entities that could pose risks to your organisation.

### ▶ Due Diligence Checks

We conduct thorough due diligence checks on employees, stakeholders, and any relevant entities associated with your organisation.

### ▶ Specific Investigations

## 6. Site Vulnerability Assessment (commercial or residential)

The outcome is a prioritised set of recommendations designed to enhance security management systems, all derived from the insights gained during the site review.

We use a five-step risk assessment methodology.

- 1 Asset characterisation
- 2 Threat scoping and analysis
- 3 Vulnerability review
- 4 Consequence analysis (health/safety, economic, infrastructure/operations, governance)
- 5 Risk ranking and gap closure recommendations
